This meet was organized under the title “Career Opportunities Series - 3” and addressed opportunities in stocks and mutual funds sector. The President formally opened the web meet. The panelists were Mr. Ravi Kumar Korada, (Director - Meliora Asset Reconstruction Company Ltd, Visakhapatnam) and Mr. N Mrutyunjaya Rao (Financial Advisor, AMFI Certified Mutual Fund Distributor, Visakhapatnam). Dr. GP Rao was the session co-ordinator. After the welcome address by the President, Dr. GP Rao introduced the moderator, Dr. Sanjukta Subudhi to the audience, who then introduced the two panelists.

Mr. Ravi Kumar Korada is a Chartered Accountant by profession. He is Partner at Sisir & Ravi Associates and Director at Meliora Asset Reconstruction Company Ltd, Visakhapatnam. Mr. N Mrutyunjaya Rao is a Financial advisor with 21 years of experience and is Certified with National institute of Securities Markets & IRDA. He has helped lot of investors with wealth creation in fulfilling their life goals like Retirement Fund, Child Education, Kids Marriage etc. The moderator, Dr Sanjukta Subudhi is a Senior Scientist & Group leader, Microbial Biofuels and Biochemical area at The Energy and Resources Institute (TERI).

The two speakers made power point presentations. The session lasted for about forty minutes and then it was followed by fielding of various questions from the audience. Dr Sanjukta Subudhi then summarized the session and also presented her own slide detailing out eligibility criteria for persons seeking this line of career.

After that, Mr. KGK Patro, joint Secretary, informed that the Samaj had an excellent celebration of the silver jubilee year which started with the Kartik Purnima celebration meet on 30<sup>th</sup> November 2020 and ended with the webinar on career opportunities in pharma and health sector on 12<sup>th</sup> December 2021. - In view of the interest shown by the youngsters during the physical gathering at Jagannath Mandir, Hauz Khas in Nov 2021, the Samaj would be starting a Kalinga Vysya Young Stars club, co-ordinated by one of the EC members. This would be open to the youth of the community (above 15 years of age) with an upper age limit of 25 years as on 1<sup>st</sup> January of the year. These young members will have their own activities and meetings. The details are being worked out and would be announced soon.
- It is also proposed to come out with the next souvenir of the samaj in this year.

This was followed by a bouquet of Hindi, Odia and Telugu songs presented by the renowned artiste Ms. Swapna Rani Patra from Bhubaneshwar, through karaoke singing. Mr. Ramprasad Patro introduced the singer to the audience. As decided in the EC meeting earlier, a cash award of Rs. 10,000 (contributed by EC members) and a digital plaque would be presented to the singer for her services.

After that the vote of thanks was presented by the Secretary, Mr. Ramprasad Patro. Finally, the forum became open. Mr. GV Ramana from Rayagada, introduced himself and aired his views about the program. Meeting concluded with thanks to the chair.

This meet was organized under the title “Career Opportunities Series – Event 4” and addressed opportunities in hospitality sector (Hotel, Travel etc.). The President formally opened the web meet. The speaker was Mr. Sheshadri Vaddi, HR Division, Trident Hotel, Hyderabad).
